Public Relations

A. Activities Performed for 2011

2/21-2/24: Lt. Dan McGee held a RAD class for freshman and sophomore girls at Montpelier Schools. This was the class portion of the RAD program.

3/1: Chief Jeff Lehman attended a "table top" exercise regarding the emergency response and evacuation of the Montpelier Hospital in the event of a tornado that strikes the hospital. Several other agencies were in attendance from the county.

3/8: Lt. Dan McGee held a RAD simulation for freshman and sophomore girls at Montpelier Schools. Admin Assistant Darrin Repp assisted with the simulations.

3/18: Sgt. Darrell Higbie held an AARP driver safety class for Senior Citizens.

3/19: Lt. Dan McGee spoke with Anthony Wyse and his 7 yr old 2nd grader for a research project for school. He spoke with her about the police department and the building. She will be presenting her presentation to her classmates and to other schools via teleconference. A patch and stickers were given to her to add to her display board.

4/19: Lt. Dan McGee attended the Williams County Children's Summit and participated in by completing a round table discussion. Lt. McGee received the Williams County Job and Family Service's 2011 "Cherish the Child award for efforts in working with children. A plaque was received by Lt. McGee for the recognition.

4/26: Chief Jeff Lehman and A/A Darrin Repp helped 3 residents take large trash items to the curb for large trash pick up.

4/27: Chief Jeff Lehman carried out box springs to the curb for a residents to be picked up for large trash pick up.

5/5: Chief Jeff Lehman attended the 2011 National Day of Prayer celebration.

The information was then forwarded to the Williams County Safe Communities Coalition for the "Buckle Up Bowl".

5/26: Lt. Dan McGee gave a tour of our department to 4 kindergarten classes from Montpelier Schools. Chief Jeff Lehman assisted with one session.

5/27: Chief Jeff Lehman attended the send off for Maddie Richmond at Montpelier Schools in reference to the "National Spelling Bee".

6/1: Lt. Dan McGee attended Career Day held for the 6^{th} grade class at Montpelier Schools where he spoke about personal protection.

6/8: Chief Jeff Lehman conducted the annual "Ohio Traffic Safety Office Safety Belt Survey." He conducted this at site 2333 W. Main St. and Monroe St.. The survey included usage and non-usage of front seat passenger and drivers safety belts. Results were then turned into the Williams Co. Health Department.

6/14: Lt. Dan McGee and A/A Darrin Repp while on duty and Sgt. Darrell Higbie and Ptl. Stormy Doctor while off duty participated in the Law Enforcement Torch Run for the Special Olympics. Along with Williams Co. law enforcement agencies we biked from the Montpelier Police Department to the County Courthouse where a small ceremony was held. Lt. McGee provided traffic control with a cruiser while Sgt. Higbie, Ptl. Doctor, and A/A Repp rode bikes.

8/2: We received 120 income tax subpoenas for 2011 to deliver for the Village Income Tax Department. The entire department help serve the subpoenas.


