#### **Public Relations**

#### A. Activities Performed for 2012

#### On Duty:

1/19: Chief Jeff Lehman attended a pre-planning meeting reference the biannual "Mock Crash". The event is scheduled for April 19<sup>th</sup> and is headed by the Williams County Safe Communities Coalition.

**2/2:** Chief Jeff Lehman attended a meeting held by the Williams County Safe Communities Coalition. The discussion was held reference the upcoming mock crash, traffic safety programs, a driving simulator, and upcoming media blitz.

**2/7:** Lt. Dan McGee attended the Williams County Children's Summit where several speakers spoke reference issues with 4-H, Community Advocates for Healthy Families, and the awakening. It was discussed about potential issues and remedies for youth problems.

**2/14:** Chief Jeff Lehman attended the Officer Phil Child Safety Program as a sponsor of the event. The funds for this event were donated by the community. The program was held for the grades K thru 3<sup>rd</sup> at Montpelier Schools.

**2/21 to 2/29:** Lt. Dan McGee was at Montpelier Schools teaching the girls PE classes grades 9-11 basic and advanced R.A.D. courses. This teaches these girls self defense skills to apply if ever needed in life.

3/5: Lt. Dan McGee put together a simulation for his R.A.D. class at Montpelier Schools, so the students could put together all the defensive skills that they were taught. Lt. Dan McGee wore the RedMan suit and protective gear. Lt. McGee was assisted by A/A Darrin Repp.

**3/19:** Lt. Dan McGee gave a tour and answered a series of interview questions for Montpelier Schools 2<sup>nd</sup> grader Taylor Collins for a project he was completing for school. Lt. McGee gave him a pencil and a toy badge to remember his visit.

**3/21:** Lt. Dan McGee gave a tour and answered a series of interview questions for Montpelier 2<sup>nd</sup> grader Jade Green for a project she was completing for school. Lt. McGee gave Jade a pencil and toy badge to remember her visit.

- 4/6to4/11: Lt. Dan McGee off and on duty did a women's self defense course and explained how self defense relates to criminal justice for Danielle Prasser from Hilltop High School. This is a project for credit for school. Ptl. Josh Mercer also participated as Danielle completed a ride along for the last 2 hrs of his shift and then she finished with Lt. McGee.
- **4/18:** Chief Jeff Lehman participated in the Williams Co. Mock Crash. This was held for the Jr. and Sr.'s of Williams Co. Schools. RPtl. Darrin Repp assisted with traffic control during the mock crash and Lt. Dan McGee was present along with other various law enforcement agencies.
- **4/23:** Lt. Dan McGee read a book to Mrs. Minors class at Montpelier Schools. They also played the shape game. The book Lt. McGee read was "Mine-o-saur" and it was about sharing.
- **4/24:** Lt. Dan McGee off and on duty spoke to the Williams Co. Children's Summit. Lt. McGee spoke about sexting, bullying, and the social media impact. Lt. McGee handed out pamphlets he created to go along with the presentation.
- **5/3:** Chief Jeff Lehman attended the annual National Day of Prayer.
- 7/31: Safety Town visited our department with Lt. Dan McGee speaking with them on what police officers do and showed various equipment used in police work. Also a tour was given of the department, cruiser, and the kids assisted in developing fingerprints. The main topic of discussion was bullying. A handout of coloring pages, pencils, stickers, and glow sticks were given to the kids.
- **8/1:** Chief Jeff Lehman attended "Story Time" at the Montpelier Public Library were the topic was "Hero's". He handed out bookmarks, sticker badges, and child id kits to all the kids present.
- **8/15:** Chief Jeff Lehman Spoke to the Williams Co. Health Dept. employees about workplace violence. Pamphlets were handed out on key indicators of potential problem employee's and information on pre-employment screening guide.
- **10/4:** Lt. Dan McGee attended the Montpelier Schools Walk-A-Thon and walked with the kids around the track promoting health.

- 11/2: Lt. Dan McGee attended the annual Halloween Parade. While there Lt. McGee handed out glow sticks to the kids.
- 11/7: Sgt. Darrell Higbie conducted an interview with Collin Whetro who is a boy scout who is writing a paper for boy scouts reference law enforcement.
- 11/15: Lt. Dan McGee conducted a Krav Maga Self Defense and fitness demo for the Montpelier School Faculty.
