SUBJECT: Dump Truck – Trash/Debris Agreement

Due to the recent concerns of the Insurance Carrier for the Village, the attached form must be completed prior to the “spotting of a dump truck” for use in hauling trash or debris from properties located within the Village of Montpelier.

It should be noted that insurance coverage is required for those utilizing this service.

Completed forms should be returned to the Village Offices at the above address. Upon receipt of the completed form a work order will be generated and forwarded to the Street Superintendent.

It should also be noted that this service is limited by the availability of trucks and Village use of these vehicles will be the priority.

## **ITEMS NOT TO BE PUT INTO DUMP TRUCK**

Tree Branches, Tree Trimmings, Grass, Yard Waste, etc.

No Liquids – Paints, Oils, Roof Coatings, etc.

No Tires or Batteries. They will be picked up separately.

No Refrigerators, Freezers, Air Conditioners,  
Dehumidifiers, or anything with freon in it.

## DUMP TRUCK – TRASH / DEBRIS AGREEMENT

**This agreement is only available to properties located within corporate limits of the Village of Montpelier**

The Village of Montpelier (hereinafter the "VILLAGE") will spot a Village dump truck (hereinafter a "DUMP TRUCK") at an agreed site and leave the DUMP TRUCK in place from the

and upon billing, shall promptly pay the VILLAGE the actual cost incurred by VILLAGE in disposing of the debris/trash at the landfill (currently at or near \$60.00 per ton) plus a spotting/hauling fee of \$35.00.

Once in place the DUMP TRUCK shall not be moved except by authorized employees of the VILLAGE.
